## Employment of Foreign Mid-level Technical Workers by Employers Application Flow Chart

In employing foreigners to perform mid-level technical work in deep sea fishing, mid-level technical institution nursing work, mid-level technical family nursing work, mid-level technical manufacturing work, mid-level technical construction work, mid-level technical extensive farming, mid-level technical agricultural work, employers shall comply with subparagraphs 8-11 of paragraph 1 under Article 46 of the Employment and Service Act respecting the eligibility, gualification and review standard of the workers. Individuals under the age of 80 determined as requiring all-day care; individuals aged 80 or over determined to be severely dependent on nursing services; individuals aged 85 or over determined to be moderately dependent on nursing services; individuals with specific physical or mental disabilities or those diagnosed to a certain level; Diagnosis of illness and disability with validity of one year individuals who have received long-term care services for more than issued by medical institutions, or certificate of handicapped 6 months; individuals assessed by a specialist in a neurology or issued by the local competent authority. The persons under psychiatric department of a medical institution with a score of more nursing care who are exempted by the central competent than 1 on the Clinical Dementia Rating (CDR) Scale. authority from the professional assessment of medical institutions are not required to present the documents.
